

Carroll County Communication District (CCCD) 01/17/2024 Meeting Minutes

Location: Annex Meeting Room, Carroll County Complex, 10 County Farm Rd., Ossipee, NH 03864 Meeting was called to order by CCCD Chairperson Linda Mailhot at 10:03 AM.

- 1. **Roll Call** See page 3 of these minutes for the roll call list of all Governing Board Members present (P), Governing Board Members present on ZOOM (Z), and voting Governing Board Members present (P). Others on Zoom: Public Glenn Coppleman
 - NOTE: the (9) voting Governing Board Town Members present in person made a quorum.
- Minutes The November 15, 2023, minutes were distributed to all Board Members by email in advance of the meeting. Sherryl Hitte motioned to approve the November 15, 2023, Meeting Minutes presented, 2nd by Bill Lord. There was no further discussion, errors or omissions and it passed unanimously by a voice vote. See vote #2 on chart below.
- 3. Treasurer's Report Sherryl Hitte reported CCCD checking account at Bank of NH (November 1-30) had a starting balance of \$15,622.18. In November USPS was paid \$70.00 for our CCCD mailbox at the Ossipee, NH post office, as well as two keys \$11.00, thus an ending balance of \$15,541.18. Bill Lord motioned to approve the Treasurer's report, 2nd by Chuck Fuller. Also, In December, there were no meetings scheduled and no monies expensed. Thus, the balance as of 12/29/23 was \$15,541.18.
- 4. Chairperson Updates –Linda announced that she had received the approval from her request for an extension to use the ARPA funds from Karen Czifrik (Carroll County Finance Department) on 12/7/2023 via email. Linda did more investigation into the value provided by spending the \$620.00 we had set aside for a membership to the NH Municipal Association during our November 2023 meeting. We assumed that legal services were part of the package. Linda learned that was not the case and recommended we rescind the \$620.00 investment. Sherryl Hitte made the motion and Linda Mailhot 2nd. There was no further discussion or questions, and it passed unanimously by a roll call vote. (10-0) See vote #4 on chart below. Linda informed us the CCCD must have insurance to cover General Liability, Property, and Workmen's Compensation (NH defines employees, appointees, and elected government groups). Primex, is the insurance vendor for the state of NH. Thus, their quote was \$541.00 (Feb.1-June 30, 2024) and \$1,300.00 (July 1, 2024- June 30, 2025). Sherryl Hitte made the motion to engage with Primex and approve the expenditure of \$541.00 only at this time and Linda Mailhot 2nd. There was no further discussion or questions, and it passed unanimously by a roll call vote. (10-0) See vote #5 on chart below.

Outreach/Information/Education Committee – Members: Sherryl Hitte (Chair), Bill Gassman, Pam Hearne. Several pieces of information were provided by Pam and John Border were shared with the CCCD including: Internet, telephone, and streaming options for the town of Eaton and Broadband Affordability Connectivity Programs (BACP) information describing how community household members can receive discounts if qualified.

Advocacy Committee – Members: Rick Hiland (Chair), Matt Plache. There was no new activity this month.

Digital Equity Committee – Members: Bill Gassman (Chair), Rick Hiland, Rich Comer, John Border. Bill suggested that we must address this issue at the town level to communicate the programs offered to minimize the monthly cost of broadband for those in need.

Other Business:

Chairperson Linda Mailhot announced Mary Cronin, an alternate representative for the town of Madison has resigned from her role effective 01/14/24. We want to thank Mary for her contributions to the committee.

Glenn Coppleman notified the CCCD the NH Digital Equity Plan (137 pages) that was shared in early January 2024 did not have the Carroll County Community District listed as a resource in the document. Linda indicated she would follow up with the state to ensure we are a listed resource.
